using value-based measurements, and one of them is the Economic Value Added

(EVA).

This research aims to discuss the analysis influence of Economic Value Added

(EVA) to stock prices on companies listed in Indonesia Stock Exchange period

2011-2013.

The type of research used in this research is descriptive research

using quantitative methods. Then for data analysis used descriptive analysis and

panel data regression analysis with t test hypothesis testing. The object of the

research in this study is the entire sector that is on the Indonesia Stock Exchange.

Based on the panel data regression testing results shows the results of the

Economic Value Added (EVA) do not affect significantly to stock prices in

Indonesia Stock Exchange. It is proved that EVA has a value of t = 0.15350 < t

table 1.96215 and preliminary results based on the coefficient of determination of

0.0022%.

From the result can be concluded that variable Economic Value Added (EVA) has

no significant effect on stock prices.
