

## **ABSTRACT**

Sampling techniques are used non probability sampling with the criteria of each 100 students that come from Bandung and 100 students from outside Bandung. Product moment correlation is used to test the validity and Cronbach Alpha was used to test the reliability of the instrument. Test Different t used to test the hypothesis.*

*Based on the results of the study, it was found that there is no difference financial literacy and financial management behavior between students from Bandung and outside Bandung at the Faculty of Engineering at the Telkom University.*
